1. **All Senior & Junior season tickets are *Restricted Use* and may be used only during weekdays and after 3:00 pm on weekends and holidays.**
2. **All applicants must produce valid picture identification or a birth certificate to prove residency or age. A resident is defined as one who actually resides in Hamden, Connecticut.**
3. **Cart rental is mandatory on weekends & holidays from April 1<sup>st</sup> through November 30, 2020 during the hours of 6:00 am to 3:00 pm.**
4. **Season Tickets are not valid during any outside Tournament, Banquet or Outing.**
5. **All season ticket holders must sign in @ the Golf Shop prior to their utilizing the golf course or range.**
6. **Triumph Golf Management, Inc./LVCC has the right to close the facility for outside events, tournaments or functions.**
7. A VIOLATION OF ANY OF LAUREL VIEW'S RULES WILL BE GROUNDS FOR IMMEDIATE SUSPENSION OF YOUR SEASON TICKET AND PLAYING PRIVILEGES. YOU WILL NOT BE ENTITLED TO A REFUND OF ANY PORTION OF YOUR SEASON TICKET.
