- All season ticket holders must register with the Pro Shop before tee off.
- Triumph Golf Management has the right to close the course for outside events, tournaments or outing without prior notice to season ticket holders.
- A VIOLATION OF ANY OF TRIUMPH GOLF MANAGEMENT, INC./ LAUREL VIEW COUNTRY CLUB'S RULES WILL BE GROUNDS FOR THE IMMEDIATE SUSPENSION OF YOUR SEASON TICKET AND YOUR PLAYING PRIVILEGES, AND THEREAFTER YOU WILL NOT BE ENTITLED TO A REFUND OF ANY PORTION OF YOUR SEASON TICKET. DAMAGE TO THE GOLF COURSE, THE USE OF ILLEGAL DRUGS, ABUSIVE LANGUAGE, OR OFFENSIVE CONDUCT WILL NOT BE TOLERATED AND WILL CONSTITUTE GROUNDS FOR YOUR REMOVAL FROM OUR FACILITY, THE IMMEDIATE SUSPENSION OF YOUR SEASON TICKET AND THE TERMINATION OF YOUR PLAYING PRIVILIGES.**
- Slow play rules as described on the P' and 10th tees will be strictly enforced. Slow players will be asked to move aside for faster players behind them or asked to leave the golf course if they cannot keep up with the pace of play.
- Season tickets may not be transferred, sold and no refunds will be given.
